

- The DVMS FastTrack [™] Model :
 - The DVMS FastTrack Model represents a phased approach to adopting and adapting a DVMS CPD Model across an enterprise and its supply chain


















NCSP® Certification Training Programs

- Accredited, Certified & Recognized Certification Training Programs:
 - NCSP Awareness course and workshop teaches employees the fundamentals of digital business, its risks, and the NIST Cybersecurity Framework's role in helping organizations mitigate risk. This course include the Fundamentals BOK publication, Certificate of Completion and a digital badge
 - NCSP Foundation course teaches employees the fundamentals of the NIST Cybersecurity Framework and how to leverage it communicate with C-Level executives about the business value a it brings to existing digital business applications and employee productivity programs. This course includes the Fundamentals BOK publication plus an exam voucher
 - NCSP 800-53 Practitioner course teaches employees a Fast-Track approach to assessing, engineering, implementing and operationalizing the NIST Cybersecurity Framework and its 800-53 security controls across an enterprise and its supply chain. This course includes the Practitioners BOK publication plus an exam voucher (implementer or auditor)
 - NCSP Specialist courses employees a Fast-Track approach to assessing, engineering, implementing and operationalizing the NIST Cybersecurity Framework and its 800-171 and ISO 27001 security controls across an enterprise and its supply chain. This course requires a Practitioner certification to attend. Course comes with an exam voucher (implementer or auditor)
